- Participants must be registered as a PAL member and have a PAL Photo ID in order to attend any program or events held at the PAL Center. There is a small fee to replace lost or stolen cards.
- Registration is accepted at **only** at the Fairfield Community Center. Membership is open to any FSUSD/Travis District student who is currently enrolled in middle/high school or any Fairfield resident age 13-18 currently enrolled in school. **(Residency/school verification is required at the time of registration.)**
- Participants must card/sign in and out each time they enter and leave the PAL Center. Members may sign in and out as necessary to meet their personal schedules and responsibilities. **An adult signature is not required for a member to leave or enter.**
- Everyone is to be treated with courtesy.
- PAL membership is a privilege. Members who are cited for infractions at school, the center or in the community may lose this privilege for up to one year or more.
- We are not responsible for lost or stolen personal items.
- Participants who do not follow the rules will need to leave the facility immediately.
- Gang attire may not be worn at any time.

**PAL Memberships are good for one year. Members must re-register with updated documentation and registration form once a year at the Fairfield Community Center.**

**The following is not permitted:**

- Foul language
- Fighting (**even “play”**)
- Bullying or teasing of any kind (including “play”) “I was just joking” does not make it ok.
- “Borrowing” (or stealing) of personal or PAL Center objects without permission of the owner
- Gum and sunflower seeds
- Gambling
- Food around / on the computers
- Sitting on anything other than a chair or the floor.
- Public displays of affection (including hugging.)
- Bouncing balls against any walls/windows or hanging on basketball nets or rims.
- Entering the boxing area except during structured boxing class times and when “dressed out.”

**Parents / Guardians are responsible for insuring that their children are picked up from the PAL Center before closing time. The Fairfield Police Department’s VIP volunteers may be available on a limited basis to offer free rides home using Police Department vans.**

**However, we are unable to guarantee these rides will be available every day, for every member. Rides will be first come, first served, when volunteers are available. Please call staff for additional information. Any student who fails to follow program rules or the direction of VIPS at any time will no longer be able to get a ride.**
